## Trust Account Money Order Instructions:

- 1. All fields must be completed and legible using blue or black ink to avoid delays in processing.
- 2. You must be on your loved one's approved or tentatively-approved visiting list to send a money order. If you are not an approved visitor, you can fill out an application at www.drc.ohio.gov and submit it to the facility where your loved one resides. The approval process may take 30-60 days, and you must receive your loved one's authorization.
- 3. There are no fees for sending Money Orders.
  - a. Make the money order payable to "GTL Financial Services" (Payment is forwarded to the Ohio Department of Rehabilitation and Correction).
  - b. Use the Incarcerated Person's full name and double check their ID number.
- 4. The maximum money order amount is \$200.00 and all money orders must be issued in US Dollars.
- 5. **The below deposit form must accompany your money order.** Detach the form to send with your money order. Do not include any staples, paper clips, stamps, cash, letters, photos or other items with your deposit. Only mail the form and the money order.
- 6. Once completed mail the money order and below deposit form to:
